VOLUNTARY PARTICIPATION. I acknowledge that I have voluntarily applied to volunteer at the Mile High Music Festival (the "Event"). I understand that as a volunteer I will not be paid for my services, that I will not be covered by nor eligible for any insurance coverage provided or maintained by AEG Live-Rocky Mountains, LLC, Starr Hill Presents-Denver, LLC and Kroenke Stadium Services, Inc. (together, the "Promoters"), Anschutz Entertainment Group, Inc., AEG Live LLC (and any affiliated entities thereof), and their respective employees, agents, officers, directors, trustees, shareholders, subcommittees, agents, members, employees, contractors, representatives, sponsors, volunteers, successors and assigns (collectively, the "Released Parties"), including but not limited to medical, property and liability insurance, and workers compensation benefits. I further agree that my participation in the Event may be terminated at any time by the Promoters.

VOLUNTEER BENEFITS. Promoters agree to grant volunteer with reasonable access to the Event after full completion of services. In order to retain such access rights volunteer must provide Promoters with the credit card information below. Volunteer's credit card will be charged the full price of a one day General Admission ticket in the following circumstances: (a) volunteer neglects to show up to the Event or (b) volunteer fails to fulfill their services.

All tickets or passes to the Event granted to volunteer by Promoters are for volunteer's use only, provided, however, any resale of the Event tickets or passes is prohibited.

ASSUMPTION OF RISK. I AGREE THAT I DERIVE A MATERIAL BENEFIT FROM MY PARTICIPATION AND/OR INVOLVEMENT IN THE EVENT. BY EXECUTION OF THIS AGREEMENT, I EXPRESSLY AND UNCONDITIONALLY ASSUME ALL RISKS AND DANGERS KNOWN OR UNKNOWN, FORESEEN OR UNFORESEEN, AND RELATING TO OR INCIDENTAL TO MY PARTICIPATION OR INVOLVEMENT IN THE EVENT AND ANY ACTIVITY ASSOCIATED THEREWITH. IN FURTHERANCE THEREOF, I AM AWARE THAT I MAY BE EXPOSED TO PERSONAL INJURY OR DEATH, OR DAMAGE OR LOSS TO MY PROPERTY AS A RESULT OF MY ACTIVITIES, THE ACTIVITIES OF OTHER VOLUNTEERS OR THE CONDITIONS UNDER WHICH MY VOLUNTEER SERVICES ARE PERFORMED. WITH KNOWLEDGE OF THESE RISKS, I AGREE TO ACCEPT ANY AND ALL RISKS OF PERSONAL INJURY OR DEATH OR DAMAGE TO MY PROPERTY, AND I VERIFY THIS STATEMENT BY PLACING MY INITIALS HERE: _____.

RELEASE. In consideration of the opportunity afforded me to participate in the Event, I hereby agree that I, my successors, assignees, heirs, guardians and legal representatives hereby release, forever discharge and hold harmless the Released Parties, for any and all claims, damages, liabilities, costs, expenses, injury, death or damage resulting from the acts or omissions of any person or entity, however caused, arising from or in any way related to my participation in the Event and all activities associated therewith. Without limiting the generality of the foregoing, I hereby waive and release any rights, actions or causes of action resulting from personal injury to me or my death, or damage to or loss of my property, sustained in connection with my participation in the Event. I further consent to the unrestricted use by the Promoters and/or any person authorized by them of any photographs, recordings, interview, videotapes, motion pictures or similar visual or auditory recording of me created in connection with the Event.

If any provision of this Agreement shall for any reason be held invalid or unenforceable, such invalidity or unenforceability shall not affect any other provision hereof and this Agreement shall be construed as if such invalid or unenforceable provision were omitted. The waiver and release granted by me hereunder is legally binding and shall be considered irrevocable. I agree that the Released Parties may rely upon this Agreement to fullest extent permissible at law or in equity.

INDEMNIFICATION. Volunteer agrees to indemnify, defend and hold harmless Released Parties from and against any and all claims, demands and causes of action, liability, judgments, damages, costs and expenses (including reasonable attorney's fees) arising out of or caused by any acts, errors or omissions or alleged acts, errors or omissions by Volunteer, in connection with Volunteer's presence on or use of the venue (including its adjacent premises and facilities) provided such claims relate only to the obligation of the Volunteer as agreed upon herein.

KNOWING AND VOLUNTARY EXECUTION. I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A CONTRACT BETWEEN MYSELF AND THE RELEASED PARTIES AND A RELEASE OF LIABILITY, AND I SIGN IT OF MY OWN FREE WILL. BY SIGNING THIS AGREEMENT, I CERTIFY THAT I AM EIGHTEEN YEARS OF AGE OR OLDER OR HAVE DELIVERED THE CONSENT OF MY PARENT OR LEGAL GUARDIAN TO THE RELEASED PARTIES. I HEREBY CERTIFY THAT ALL INFORMATION PROVIDED BELOW IS TRUE, ACCURATE AND COMPLETE IN ALL RESPECTS.
